**\*Please note that in the process of buying wooden furniture which are mainly made out of timber material, manufactures should give priority to use STC timber when required by the STC to assure the quality of the timber. Manufactures are required to follow quality measures for other non-wooden material as suggested by STC.**

- A. Last date & time of issue of application forms: 2023.06.23 until 3.00 p.m.
- B. Applications should be forwarded by Registered post addressed to the Deputy General Manager (Marketing) , State Timber Corporation – Marketing Division ,”Sampathpaya”, 82, Rajamalwatte Road, Battaramulla to reach on or before 2023.06.30 until 11.30 a.m..The Top left hand corner of the cover should be marked **“Registration of Suppliers for Wooden Products, Wooden Crafts & Wooden furniture - Year 2023”**.
- C. Application forms for each main Item for registration could be obtained in Sinhala & English Language **upon written request on supplier’s letter head** and on a cash payment of non – refundable document fee of **Rs.500/=** from the Deputy General Manager (Marketing), State Timber Corporation, ,”Sampathpaya”, 82, Rajamalwatte Road, Battaramulla.Registration Last date - **2023.06.23**
- D. Cheques / Money orders and postal orders will not be accepted.
- E. Applications should be send by suppliers those who can provide followings,  
(The following criteria are used to evaluate the suppliers)
  - Services provided after the warranty period
  - Free transportation in island wide
  - Free installation
  - Manufacture Authorization Required
  - Respond immediately
  - Supply required furniture within 07 days after order is placed (If stock available).
  - Ability to supply Fixed price
  - Ability to supply credit period
  - Ability to present sample in Battaramulla, Rathmalana & Boossa showrooms
- F. Quotations for Supplies will normally be called for from the List of shortlisted registered suppliers.
- G. The Corporation reserves the right to accept or reject any application sent for registration.
