- C. Suppliers of outside Colombo district can register at our regional office by paying a non-refundable document fee of Rs.500/= per each main category & collect relevant documents from the Regional Manager.
- D. Quotations for Supplies/Services will normally be called from the List of registered suppliers, but the State Timber Corporation reserves the right to select suppliers to call for quotations even outside the Registered List, in view of obtaining competitive offers.
- E. Suppliers and Contractors who are registered with the corporation for 2024 are requested to send fresh applications for year 2025.
- F. The Corporation reserves the right to accept or reject any application sent for registration.
- G. Any clarification or further information, if required, could be obtained from the Manager (Purchasing & Shipping).
- H. It is required to submit both online application and duly filled downloaded application through register post (with requested documents and original payment receipt for registration) through register post.
