- building over a 10-year period. 5. Eligibility Criteria

To be eligible for submitting EOI, the successful Information System solution

service provider shall not have been blacklisted. The qualification criteria for the eligible Solution Providers shall include the following. (Additional qualification requirements are given in EOI calling documents). a) General Experiences

Expressions of Interest must be submitted by a qualified IT services

- provider legally established in Sri Lanka. The proposed IS solution service provider shall have a minimum
- of seven (7) years of experience, within the past ten (10) years, in developing customized software solutions in Sri Lanka or overseas b) Specific Experience in contract of similar nature:

- The IS solution must have successfully completed at least two (2) assignments during the last ten (10) years involving Business Process Reengineering (BPR) combined with system implementation.
- ii. The Solution Provider should have successfully completed at least two (02) system implementation projects, supported by reference letters. The minimum value of each project must not be less than LKR forty (40) million , and the projects must have been completed within the last Ten (10) years prior to the Bid Submission Deadline.

c) Average Annual Turnover and Financial Resources

The firm must have an average annual turnover of at least LKR seventy five (75) million over the past five (5) years and average working capital (Current Assets – Current Liabilities) over the past five (5) years must be LKR twelve (12) million.

- d) Quality and Security Requirements
 - iii. Bidder shall be certified with ISO 9001:2015 and ISO 27001
